Matco-Norca will replace, free of charge, during the warranty period, any part which proves defective in material and / or workmanship under normal installation, use and service. **Matco-Norca's** obligation under this warranty shall be limited to the replacement of any parts which proves defective upon **Matco-Norca's** inspection of such product. Replacement parts can be obtained by returning the defective part to your local **Matco-Norca** dealer, transportation charges prepaid, with a copy of the purchase receipt or by calling 1-888-328-2383.
